### 03. RELAXATION OF AGE AND OTHER CONDITIONS:-

(i) In addition to the relaxation of upper age limit of 3 & 5 years available for OBC & SC/ST categories respectively, a another relaxation in age limit is allowed in accordance with DOPT Om No. 2/3/84-Estt(D) dated 12.11.1987 to a maximum of 05 years (10 years in case of those belonging to SC/ST) for the categories of sports person specified in above para for all categories of Sports Persons including General/Unreserved category.

(ii) Relaxation of age shall be considered in respect of Ex-servicemen and PwD candidates as per the DOPT guidelines in addition to the other relaxations like community and sports persons.

(iii) Reservation Rule for sports quota is only for claiming the exemption in age relaxation. Such candidates should necessarily submit proof of age i.e. SSC Certificate and Caste Certificate for claiming exemption in age relaxation.

(iv) The concession will be available only to those sportspersons who satisfy all other eligibility conditions relating to educational qualifications etc and furnish a certificate in the form from an authority prescribed in these instructions.

(v) No appointment can be made unless the candidate is in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of category of persons to which the applicant belongs.

## 06. ELIGIBILITY

(a) Appointments under these orders can be made of sportspersons considered meritorious with reference to the following criteria:

i) Sportsmen who have represented a State or the country in the National or International competition; or Medal winners in Junior National Championships; or Medal winners in Khelo India Youth Games (age category above 18 years); or Khelo India Winter Games or Khelo India Para Games; or Medal winners in Khelo India University Games; or Medal winners in School Games Federation of India (SGFI) in any of the games/sports mentioned in these instructions.

For Chess: Grand Master (GM) Title, International Master (IM) Title, Chess Olympiad. IM/GM title should be in Open Category like Woman Grandmaster (WGM) etc. While National Open Chess Championship is treated as National Championships, the medal winning performance in National Team Chess Championship will also be considered for recruitment.

ii) Sportsmen who have represented their University in the Inter-University Tournaments conducted by the Inter-University Sports Boards in any of the sports/games specified in these instructions, as amended from time to time.

- iii) Sportsmen who have represented the State School Teams in the National Sports/games for schools conducted by the All India School Games Federation in any of the games/sports mentioned in these instructions.
- (b) No such appointments can be made unless the candidate is, in all respects, eligible for appointment to the post applied for, and in particular, with regard to age, educational or experience qualifications prescribed under the Recruitment Rules applicable to the post, except to the extent to which relaxations thereof have been permitted in respect of class/category of persons to which the applicant belongs.

- (i) A complete list of all applicants whose applications were received on or before the closing date will be displayed on the notice board and on the official website of CGST & CX Ranchi Zone Patna at <https://cgstranchizone.bih.nic.in/circular.html>. If an applicant's name



is not included in the list, he may submit a claim within 15 days from the date of disclosure. The claim must include documentary proof that the application was submitted by him on or before the closing date.

- (ii) The applications shall be scrutinized, and eligible candidates shall be shortlisted on the basis of evaluation of their performances, age and highest achievement in their career in respective sports events. For each post, a separate panel of eligible candidates shall be prepared based on the total applications received. This panel shall be displayed on the notice board and on the official website. The reasons for each candidate's inclusion in the panel shall also be provided. If any candidate disagrees with the information, they must inform the department within 15 days of the panel's disclosure. Claims should be submitted by either email or speed post. Please note that anonymous claims will not be entertained.
- (iii) All the such eligible candidates whose name has been included in the panel shall be called for appearance before the Committee for verification of the relevant original documents submitted by them along with their applications. In this regard, only those documents whose copies are already submitted with the applications by the concerned applicant with proper attestation shall be taken into consideration by the Committee. Any other documents submitted thereafter shall not be considered.
- (iv) Order of preference
  - (a) First preference to those candidates who have represented the country in an International Competition with the clearance of the Department of Sports, Ministry of Youth Affairs and Sports.
  - (b) Next preference may be given to those who have represented a State/U.T. in the Senior or Junior Level National Championships organized by the National Sports Federations recognized by Department of Sports, Ministry of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions upto 3<sup>rd</sup> place. Between the candidates participating in Senior and Junior



National Championships/games, the candidates having participated and won medal in Senior National Championship should be given preference.

- (c) Next preference may be given to those, who have represented a University in an Inter-University competition conducted by Association of Indian Universities/Inter University Sports Board or Khelo India University Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions upto 3<sup>rd</sup> place in finals.
- (d) Next preference may be given to those who have represented a State/UT in Khelo India Youth Games (age category above 18 years) or Khelo India Winter Games or Khelo India Para Games conducted with authorization of Department of Sports, Ministry of Youth Affairs and Sports and have won medals or positions upto 3<sup>rd</sup> place in finals.
- (e) Next preference may be given to those who have represented the State Schools in the National sports/games for Schools conducted by the All-India School Games Federation and have won medals or positions up to 3<sup>rd</sup> place.
- (f) Next preference may be given to those who represented a State/Union Territory/University/State Schools Teams at the level mentioned in categories (b) to (e) but could not win a medal or position, in the same order of preference.

Note i: In the event of tie those who have secured a higher position or won more than one medal may be given the preference.

Note ii: Participation in individual and team event/item may be given the same preference.

Note iii: No preference may be given for winning more than one medal/position.

Note iv: In case of any doubt about the status of a tournament, the matter will be decided by the Department of Personnel & Training in consultation with Department of Sports, Ministry of Youth Affairs and Sports.

Note V : In case of Team games, preference of selection for recruitment will be

given to those candidates who have actually played and participated as a playing member as compared to those who were included in the team but did not actually play.

- 09.** Selected candidates will be required to give an undertaking to the effect that they shall not apply for Inter-Commissionerate Transfer to other Zone as there is no provision for ICT in the Recruitment Rules of Tax Assistant and Havaladar.
- 10.** Sportspersons who are already employed in Central Government or State Government or PSU should attach a No Objection Certificate (NOC) from the present employer.
- 11.** Self-attested copies of all documents in support of claim regarding the date of birth, educational qualifications, sports eligibility certificates, caste certificates, etc. should invariably accompany the application. Further, latest passport size self-attested colour photograph shall also be pasted on the application form in the space provided for the purpose.
- 12.** Sports achievements certified by the recognized authorities (Annexure II) in specified forms (Specimens forms given in the Annexure-III) will only be considered. In this connection, the list of recognized National Sports Federations for the sports/games mentioned in Para-01 is given in Annexure-IV.
- 13.** The candidate must be in possession of the requisite educational qualification for the concerned post as on closing date of receipt of application.
