Consequent to the recommendation of the DPC in the meeting held on 25.06.2024, the following officers in the grade of Lower Division Clerk of CGST & CX, Ranchi Zone, Patna are hereby promoted, on in situ basis, to the grade of Tax Assistant, Group 'C' in Level-4 of Pay Matrix of Rs. 25,500 - 81,100 (7th CPC) plus other allowances as admissible with immediate effect or from the date they assume the charge of the promoted post, whichever is later: -

- 2. The Order shall be subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others) and all other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- 3. Necessary compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 12.07.2024 positively by respective Commissionerate.
- 4. The Inter-se-seniority of the above promoted officers will be decided separately.
- 5. The promoted officers should exercise option for fixation of pay in terms of FR 22 (I)(a)(1) within one month from the date of joining as Tax Assistant and option once exercised will be final. However, if the officer has already been granted financial up-gradation under MACP Scheme then he will not be entitled for any fixation benefit.
- 6. The officers promoted through this Order shall assume the charge of promoted post in the same office where he is currently posted, till his posting in the promotional grade is
- 7. The Controlling officer shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he should not be allowed to assume charge of the post of Tax Assistant and this fact should be reported to this office immediately. Further, if the officer figuring in this Estt. Order is undergoing any penalty; he should be allowed to assume charge of the post of Tax Assistant only after expiry of the currency of the penalty period. This fact should also be reported to this office.
