Consequent to the recommendation of the DPC in the meeting held on 14.12.2023, the following officers in the grade of Havaldar/MTS of CGST & CX, Ranchi Zone, Patna are hereby promoted, on in situ basis, to the grade of Lower Division Clerk (L.D.C.), Group 'C' in Level-2 of Pay Matrix of Rs. 19,900-63,200 (7<sup>th</sup> CPC) plus other allowances as admissible with immediate effect or from the date they assume the charge of the promoted post, whichever is later: -

- The Order shall be subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others) and all other litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- Necessary compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 29.12.2023 positively by respective Commissionerate.
- The Inter-se-seniority of the above promoted officers will be decided separately.
- The promoted officers should exercise option for fixation of pay in terms of FR 22 (I)(a)(1) within one month from the date of joining as Superintendent and option once exercised will be final. However, if the officer has already been granted financial up-gradation under MACP Scheme then she/he will not be entitled for any fixation benefit.
- The officers promoted through this Order shall assume the charge of promoted post in the same office where he/she is currently posted, till his/her posting in the promotional grade is decided.
- The Controlling officer shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he/she should not be allowed to assume charge of the post of LDC and this fact should be reported to this office immediately. Further, if the officer figuring in this Estt. Order is undergoing any penalty, he/she should be allowed to assume charge of the post of LDC only after expiry of the currency of the penalty period. This fact should also be reported to this office.
