2. All Pr Commissioners/Commissioners are requested to initiate prompt action for completion of Service book/Records of the concerned officers posted under their jurisdiction. It is also

requested to ensure that the Pension papers are assessed and submitted expediently in Form-7 to the concerned Pay & Accounts officers, CGST & CX/Customs, to enable the retiring officers/staffs to get their pensionary benefit in time.

3. Retiring officers should be intimated and the forms under CCS (Pension) Rules, 1972 be provided to them well in advance to ensure that the papers are processed in time and all dues are paid to retiring officers/staffs on the date of their superannuation.
4. Further, it is requested to verify the Date of Birth of the retiring officers from their service book records. In case any discrepancies are found in the list, the same should be intimated to CCO/CCA within 15 days so that the fact can be checked-up/rectified accordingly.
5. If, there is any officer/staff, who is due to retire from 01.01.2024 to 31.12.2024 but his/her name is not mentioned in this list, such name may please be intimated to CCO/CCA immediately for necessary correction/rectification.

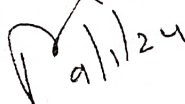
