
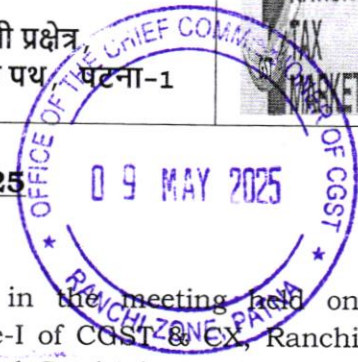




Consequent to the recommendation of the DPC in the meeting held on 05.03.2025, the following officer in Staff Car Driver Grade-I of CGST & CX, Ranchi Zone, Patna is hereby promoted to Staff Car Driver (Special Grade) in Level-6 of 7th CPC Pay Matrix (PB-2 Rs. 9,300-34,800) plus other allowances as admissible with effect from the date he assumes the charge of the promoted post: -

- The promotion order is subject to the outcome of any further orders that may be issued by the Hon'ble Supreme Court of India in SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others). The Order shall further be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- The promotion of the officer mentioned in the above table shall initially be **on in-situ basis** till the time further specific posting order is issued.
- The inter-se-seniority of the above promoted officer will be decided separately.
- The promoted officer should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Staff Car Driver (Special Grade) and option once exercised will be final. However, if the officer has already been granted financial up-gradation under ACP/MACP Scheme, he would not be entitled for any fixation benefit now.
- The Controlling Officer shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he should not be allowed to assume charge of the promoted post and this fact should be reported to this office immediately. Further, if the officer figuring in this Estt. Order is undergoing any penalty; he should be allowed to assume charge of the promoted post only after expiry of the currency of the penalty period. This fact should also be reported to this office
