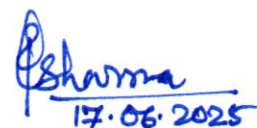
2. Head of offices are requested to verify the actual date of entitlement of each officer for financial up-gradation under MACP Scheme from their Service Books before fixation of pay.

3. In view of the clarification contained at Para-6.2.1 of DoPT O.M. No. 22011/5/86-Estt.(D) dated 10.04.89, the DSC, in some cases, considered APARs for the previous period where the relevant APARs were unavailable. In case, the presently un-available APARs resurface in future and on perusal of the same, if it is found that the grading therein is below benchmark, the MACP now being granted would be withdrawn.

4. The controlling officer shall ensure that if any of the officers whose name figures in this Estt. Order is under suspension or facing any charge-sheet or prosecution, he/she shall not be contemplated for disbursement of financial upgradation and this fact should be reported to this office immediately. Further, if any of the officers figuring in the Estt. Order is undergoing any penalty; his/her Pay should be fixed only after expiry of the currency of the penalty period. This fact may also be reported of this office.

5. The concerned officers should exercise option for fixation of pay in terms of FR-22(I)(a)(1) within one month from the date of receipt of this order and option once exercised will be final.
