- 2. The promotion order is subject to the outcome of any further orders that may be issued by the Hon'ble Supreme Court of India in SLP (C) No. 30621/2011 (Jarnail Singh and others Vs. Lachhmi Narain Gupta and others). Further, the Order shall be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
- 3. The promotion of the officer mentioned above shall initially be **on in-situ basis** till the time his further specific posting order is issued.
- 4. The inter-se-seniority of the above promoted officer will be decided separately.
- Necessary compliance report regarding joining/non-joining in respect of the officer promoted should be sent by the Commissionerate concerned within 07 days of issuance of this order positively.
- 6. The promoted officer should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Administrative Officer and option once exercised will be final. However, if the officer has already been granted financial upgradation under ACP/MACP Scheme, he would not be entitled for any fixation benefit now.
- 7. The Controlling officer shall ensure that if any officer whose name figures in this Estt. Order is under suspension or facing any charge sheet or prosecution, he should not be allowed to assume charge of the post of Administrative Officer and this fact should be reported to this office immediately. Further, if the officer figuring in this Estt. Order is undergoing any penalty; he should be allowed to assume charge of the post of Administrative Officer only after expiry of the currency of the penalty period. This fact also may be reported to this office.
